agree to the following rules and conditions concerning the use and responsibility of any consignment (hereafter referred to as "trunk show box") from Nirvana Beads Corp:

- I agree that the merchandise that I receive as part of the trunk show box is the property of Nirvana Beads Corp until I pay the listed wholesale price of each item received with the box in full.
- I agree that I am fully responsible for the contents of the trunk show box, and will either return them 30 days following my receipt of the goods or on the return date printed at the top of the packing list that arrives with the trunk show box.
- I agree to pay the full wholesale amount listed for each item in the trunk show box that is not returned to Nirvana Beads Corp, after the consignment period is over, and in the case of a discount, only deduct the amount that is allowed in the written trunk show discount policy.
- I agree that I am responsible for the safe return of the Trunk Show Box and all its contents. All boxes must be returned to Nirvana Beads at the following address:

- I agree that in the absence of my business being viable financially or legally, i will take full personal responsibility for the trunk show box, and pay for any returned merchandise.
- By signing this agreement, I understand that I agree to abide by these rules and condition for all future trunk show boxes I receive from Nirvana Beads Corp., until and unless I am notified of any changes in the contract.

Further Agreements:

- I agree to inform Nirvana Beads Corp. about any merchandise that is not received but listed in the packing list before I sell any merchandise. Same for any damaged goods received. I also agree to inform them about merchandise that is received but not listed in the same packing list.
- I agree NOT to remove or alter any of the tags attached to the trunk show box merchandise. If a significant number of tags have been altered or removed, I agree to pay a \$50 penalty.
- I agree to return the goods in the same condition in which I received them, and pack them in a safe and appropriated manner. I understand that damaged goods that are returned will be charged for as if they were bought.

Nirvana Beads

- I agree to keep the strands bound to the hanks they came in. I understand that a \$50 re-binding charge will be charged if a significant number of the strands are not in their hanks.
- I agree to return the merchandise either 30 days after my receipt of the trunk show box or on the date written at the top of the packing list, whichever is later. If the return date has been extended with the written permission of a representative of Nirvana Beads Corp., the new return date may apply.
- I agree to calculate the amount owing for the returned portion (portion sold or bought) of the merchandise before returning the box to Nirvana Beads Corp.
- I agree to include a payment by check for the unreturned portion of merchandise at the same time the box is due, or otherwise indicate that I would like Nirvana Beads Corp. to charge my credit card for the amount owing (and will have that amount available on my credit card on the due date for the trunk show box).
- I agree that Nirvana Beads Corp. may count and verify my calculation for the trunk show box, and either refund or charge my account for any difference they find, after informing me first.
- If the box is not returned 14 days after the return date (or extended return date), I agree to allow Nirvana Beads Corp. to charge the credit card they have on file for the full wholesale amount of the trunk show box.
- I understand that should I fail to pay or return any merchandise in the trunk show box within a reasonable amount of time following the return date, or fail to comply with the spirit of this agreement, Nirvana Beads Corp. may take further measures in collecting what is owed, including, but not limited to, imposing a 25% collection surcharge on the wholesale dollar amount of the trunk show box, contracting a collection agency, contracting their industry references to inform them about my delinquency, or initiating a legal suit.
